

ASSEMBLY:

MATERIAL CONTROL:

FULL TRACEABILITY SHALL BE PROVIDED FOR THE GOODS THROUGH THE SUPPLY CHAIN FROM THE MANUFACTURER THROUGH TO DELIVERY TO BAE SYSTEMS, COVERING ALL STOCKISTS / DISTRIBUTORS, INTERMEDIARIES AND MANUFACTURERS.

RELEASE DOCUMENTATION (IE. CERTIFICATES OF CONFORMITY) SHALL BE AUTHORISED BY THE QUALITY AUTHORITY, OR THEIR DELEGATED NOMINEE.

SERVICE PROVISION:

PURCHASING AND MANAGEMENT OF AIRCRAFT DETAIL / SUB ASSEMBLY PARTS FOR THE HAWK & HARRIER PROGRAMMES.

A FIRST ARTICLE SHALL BE PERFORMED ON THE FULL PRODUCTION CONFIGURED ITEM THAT IS MANUFACTURED, ASSEMBLED, PROCESSED AND TESTED IN THE SAME MANNER AS THAT INTENDED FOR SUBSEQUENT PRODUCTION ITEMS IN ACCORDANCE WITH BAE SYSTEMS PROGRAMME REQUIREMENTS.
